CALL TO ORDER:

Meeting called to order at 7:40pm.

ROLL CALL:

All clubs represented except Greenhaven.

VISITORS:

Jordan Lang, Sac United Field Coordinator – re: survey of organizations using Sac City Parks fields.

APPROVAL OF MINUTES:

It was noted that Robert Vidrio's email address is incorrect.

Good of Game - correct spelling is Ramiro Cruz.

Head Coach Report - add, "West Sac Manager" before Dale Davis' name.

Robert Sperry motioned to approve minutes as changed, seconded by Martin Brady.

FIRST VICE REPORT:

Sarah Najarro – no report.

Also has nothing to report from last month's District meeting.

HEAD COACH REPORT:

Steve Martinez reported that the first two coaching clinics are complete. Greenhaven - 22 coaches, and Dixon - 30 coaches.

Upcoming clinics – Woodland E 6/24-26 (12 signed up), South Florin F, 7/15-16 (11 signed up), Goalkeepers clinic 7/29-30, and Greenhaven F 8/5-6

Upcoming D clinics in Burlingame 6/15-19, and at UOP Stockton 7/13-17.

Recommends all your coaches get their F licenses this year.

HEAD REFEREE REPORT:

Don Spicklemeier - referee registration forms are available on the website or tonight.

Woodland completed in May – 8 people attended and passed.

Greenhaven is in the second week – 26 in attendance.

Ed Foster is teaching both courses. Doesn't know who will teach the East Sac course starting on Tuesday 6/21.

Reminder – Don is out of town the next two weeks. If anything is mailed to him he will not get it until he returns. Most of the people registered are affiliated with SYSL. He'll be back before the Dixon clinic. Following East Sac, is Dixon, then Land Park, then South Florin.
