# **CALL TO ORDER:**

#### **FIRST VICE REPORT:**

Sarah Najarro filled PAD representatives from each club. PAD reps need to email Sarah by Wed. of their scheduled week. Game cards need to be filled out on BOTH sides.

# **HEAD COACH REPORT:**
