# **HEAD COACH REPORT:**

#### TREASURER'S REPORT:

No report. Sac United still owes \$200 for an outstanding fine.

#### **REGISTRAR'S REPORT:**

The Metro teams were all due and all but two were fine...the two were still missing forms and such. Lamination nights are coming up at the end of July and the beginning of August. Registration numbers are at 75% of last year to this point. We're at 6.470.

# PRESIDENT'S REPORT:

At the June District meeting, Marlene reported that Division 1 teams may now play in Division 3 or Division 4 tournaments if approved by the District 6 commissioner, Kathy Ayala.

The District has issues with referee assigners. Rancho Cordova is having an assigner course. Check their website for the details. Only 2 of SYSL's 15 clubs have licensed assigners (by a count of hands).

The August mandatory meetings out in Orangevale are Tues. Sept 1 for up through U-14's and Wed. Sept 2 for U-16 and U19. One of the coaches on your goldenrod must attend.

South Florin is working on the design of the SYSL pin and will bring it to the next meeting for approval.

#### **NEW BUSINESS:**

Land Park motioned to approve River Park's change in uniform. Southgate seconded. Motion passed unanimously.

Dixon questioned whether West Sac teams should have to stay and play in WS and not use Dixon fields or referees. Marlene stressed that we are a league. There is a crossover because now clubs are now in charge of getting fields rather than SYSL. Clubs need to work together.
