#### HEAD REFEREE REPORT:

New Heading Rule:

9V9 deliberate heading in goal area, ball is taken straight out taken parallel to goal area and indirect kick is taken, wall can be formed. Heading violation outside goal area, parallel with penalty area line, indirect. 7v7 on down, we don't worry about goal area. Anywhere that the referee calls a header by offensive team, goes all the way out to top of penalty area, outside

12 and under cannot head. Coaches must inform referee. Be proactive. Referees should also be proactive and we understand the difficulty. If the ball is headed into the goal, he can let it go, and talk to the player. If whistle is blown before it crosses the goal line then it will be brought back.

All club managers must train and talk to coaches about header rules, there should be no surprises. Judgement call of the referee if it is deliberate or not.
